General membership meetings are held on the first Tuesday of every month at 7:00 p.m. in the DSRPC Club House located on the range. All members are welcome to attend.

Executive board meetings are held on the fourth Tuesday of every month at 7:00 p.m. in the DSRPC Club House located on the range. If you have any business to take before the E-board, contact them in writing, at the club address, so you can be put on the agenda and they will let you know the date and time to be there.

In addition to meetings, there are competitions, work parties and social events. We hope to see you often. You will receive "THE SPORTSMAN", our newsletter, each month with a calendar of events. A list of officers and match directors is also included in each newsletter. So, if you have any questions or comments, please do not hesitate to call. Please be sure to **notify us of any change of address or telephone number promptly**; you won't want to miss out on newsletters or other special announcements, which we send.

The combination to the range lock is Club property. Releasing this combination to anyone who is not a Club member is a rule violation. Violation of the rule will result in a \$50 fine and failure to pay the fine will result in expulsion from the Club. Main Gate combinations will be found in the newsletter, and are changed every month after the general meeting. **Do not give out the combination to non-members!**

Range Safety Officers are here to help YOU!!! Among their duties is to make sure the range rules are being followed and assist members in any way they can. Please give them your cooperation.

There have been problems with vandalism of locks on the gate, and with trespassing during construction and other times that it has been necessary to close the range. If there is a key or a combination lock that does not work with the newsletter combination, it means the range is closed for an important reason. Please do not cut the lock, fill it with sticks or super glue etc. Also do not drive around the main gate to get in. These things constitute vandalism & trespassing and will cost you your membership.

Application Package Instructions -

The following items are required to process your new DSRPC membership.

- ? Completed application (marked as Pg1, Pg2, Pg3 & Pg4).
- ? DSRPC membership fees (check, money order or Credit Card info) must be sent with application.
- ? Completion of Range Safety and Orientation Seminar (**within 2 months of submitting application**).
- ? **Legible** copy of current driver's license, passport or state picture id card (**must contain date of birth**)
- ? You must have a current NRA membership so include one of the following:
 - o **Legible** copy of current NRA magazine mailing label
 - o Or **Legible** copy of NRA membership card (must contain, your name, NRA membership #, and expiration date)
 - o Or go to <https://www.nramemberservices.org>, login to view your membership information, print the screen and send it in with this application.

Range Orientation Seminar Information

As part of the application process for membership, you are required to attend the DSRPC Orientation and Safety Class concerning club administration, policies, safe firearms handling, and range safety rules.

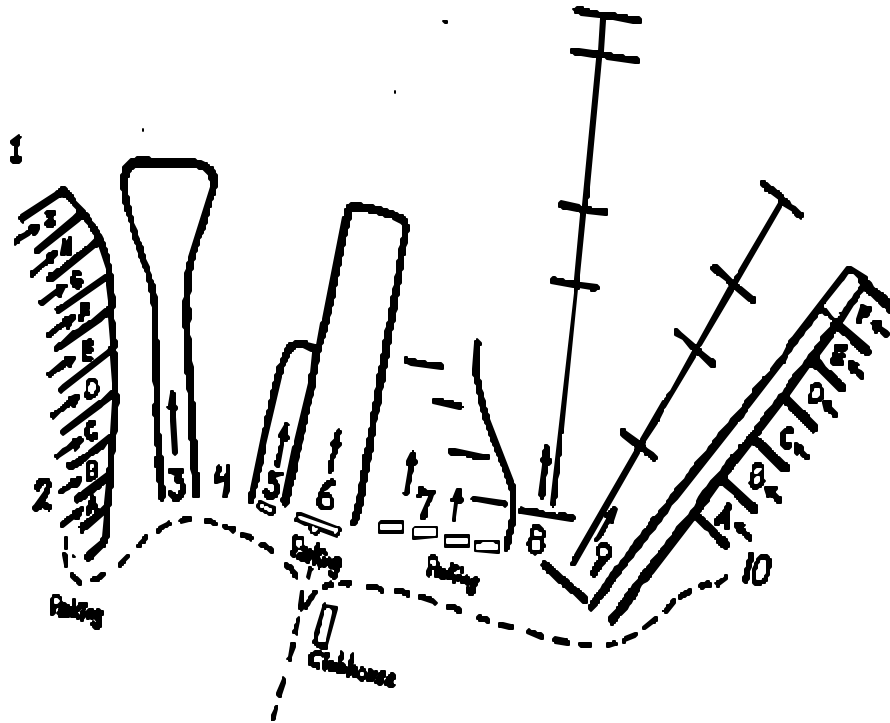
Once your application has been approved by the E-Board, final processing will remain pending until Membership Services receives notification you have attended the Orientation Seminar. **After two months, if you have not attended the Orientation, your application will be returned to you.**

Orientation will be held at the Range Clubhouse (*located at the DSRPC Range, 12201 W. Charleston Blvd, approximately 1.5 miles west from the intersection of Route 215 and W. Charleston Blvd*) from 9:00 a.m. - 11:00 a.m.

Seminars in January through October will be held on the fourth Saturday of each month,

Seminars in November and December will be held on the second Saturday due to the Thanksgiving and Christmas holidays.

To arrange for attendance at a seminar, contact DSRPC @ 702 642-9928, and leave a message on the telephone voicemail with your name, telephone number, and the date you will be attending. You will receive a return call if for some reason the class is cancelled. Please do not arrive at the range without contacting DSRPC as there will not be a seminar if no one notifies the club in advance of his/her attendance.



- Range #1: Not used at this time. No Shooting.
- Range #2: IPSC - Cowboy - Machine Gun - IDPA - Steel Challenge. Regular club members shooting pistol-rifle-shotgun & machine gun. Shoot into berms ONLY, not into the air or into the ground at any angle.
- Range #3: Long range rifle and shotgun (slug rounds only) into berm ONLY.
- Range #4: Not used at this time. No Shooting.
- Range #5: Rifles ONLY. Shoot into berms ONLY. NO HANDGUNS unless under direct match supervision.
- Range #6: Benchrest Rifle, Vintage Military bolt Action. Rifle and rifles in general. Shoot into berms ONLY- NO HANDGUNS unless under direct match supervision.
- Range #7: IHMSA, Metallic Silhouette shooters ONLY, .22 Rimfire rifles, Lever Action-lead or loaded down ONLY. Shoot ONLY into berms. Shooting at steel silhouette targets for IHMSA shooters ONLY.
- Range #8: Open for High Power Rifle matches only.
- Range #9: Open- Long Range Rifle Silhouette. Shoot into berms ONLY.
- Range #10: Bay "A" thru "F" Handgun, Shotgun. Shoot into berms only.

AFTER SHOOTING: CLEANUP THE AREA YOU USED. PICK-UP ALL SHELL CASINGS, TARGETS, TARGET STANDS, TRASH, ETC. PUT IN TRASH CANS OR TAKE WITH YOU.

Authorized targets include, Paper, Cardboard, Coroplast and steel plates... If you are observed using unauthorized targets on any range, your membership will be terminated.

Remember that when someone is setting up targets, firearms are not to be handled!

Use of the range for instruction, matches, or training for personal gain or profit by members, or for anything other than their own and their family or guests personal pleasure, is strictly prohibited without prior approval from the Executive Board. Individuals who do so are subject to having their memberships revoked without compensation. This includes all members, annual and life.

Just a reminder, each member is allowed to bring, and is limited to, 4 guests per visit.

In consideration of the acceptance of my application for entry in Desert Sportsman Rifle & Pistol Club Inc., I hereby freely agree to and make the following contractual representations and agreements.

REPRESENTATIONS

I acknowledge that, as a firearm owner, I fully realize the dangers of participating in firearm related events, and not limitation, the following:

- ? The danger of death or injury from flying fragments and bullet ricochets; and/or
- ? The danger of death or injury arising from gunshot wounds, whether inflicted by myself or another person; and/or
- ? The danger of death or injury from overcharged ammunition or firearm malfunction.

COURSE TERMINATION

I acknowledge the right of the range office and/or match director to terminate my participation immediately upon any failure of mine to comply with the rules of the range or competition and the directions of the range office and/or match director. I agree that it is my responsibility alone to be familiar & comply with all applicable rules.

WAIVER

I hereby waive, release and discharge for myself, my heirs, executors, administrator, legal representatives, assigns, and successor in interest (hereinafter collectively "successors") any and all rights claims which I have or which may hereafter accrue to me against the DSRPC, the match director and the range officers and the range owner (and their respective agents, officials and employees). Any and all damage, which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the DSRPC, or travel or return from the event.

BINDING AGREEMENT

I agree for myself and my successors, that the above representations are contractually binding and not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any subsequent waiver or modification.

Range Safety Rules - Including, but not limited to:

1. Always point the muzzle in a safe direction, Always keep fingers off the trigger, and outside the trigger guard until ready to shoot. Always keep the action open and firearm unloaded until ready to use. On a firing range this implies being in position on the firing line and only after the range has been cleared for live fire
2. Be sure the gun is safe to operate, Know how the gun operates, Wear eye and ear protection as appropriate.
3. Be sure that the firearm and ammunition are compatible. No tracer, incendiary, exploding, or armor piercing bullets are to be used on the range, Be aware that certain types of guns and shooting activities require additional precautions.
4. Be sure of the target and what is beyond. When on shooting ranges, also be aware of what is adjacent to the range and backstop.
5. It is mandatory that all members wear their club membership card prominently displayed on their person while on DSRPC property, Persons under the legal age of consent may not use the range without proper supervision or certification.
6. The use of alcohol and/or recreational drugs is strictly prohibited. Non-observance of this rule will get you expelled from the club property. If you are a member you will lose your membership. This is a zero tolerance rule. **ALCOHOL AND FIREARMS DO NOT MIX.**
7. Know and obey all range commands, Do not give out the gate combination to non-members and keep the gate closed.
8. Know where others are at all times. Keep off the berms. Designate someone to act as a Range Officer when none are present or assigned.
9. Shoot only at authorized targets. Bring your own targets and target stands. The club does not provide members with targets or targets stands. All target supports will be removed when leaving the range. Use of rocks, glass, bricks, blocks, trees, golf balls, padlocks, etc. as targets is prohibited. Illegal target stands include trash barrels, storage containers, clubhouse, restrooms; rifle racks tires, chairs, tables, etc. No vandalism of club property will be tolerated. Anyone caught vandalizing club property will lose his or her club membership.
10. Height of targets and your position shall be adjusted so the fired projectile impacts the berm and not the floor of the range. This will prevent ricochets. **DO NOT SHOOT OVER BERMS.** Targets must be set in front of berms. Targets will not be placed on top of berms.
11. Open, unload and secure all firearms during cease-fires. Do not handle firearms or stand at the firing line when others are downrange, Accidental discharges, damages or, injuries, must be reported to the Range Safety Officer immediately, no matter how minor they may seem, Only those firearms authorized on a given range facility will be allowed, Shooting is allowed only in designated areas as outlined in the club newsletter, All firing will be done with designated firing lines or positions.
12. All firearms will be unloaded when brought to the rifle range. Firearms will be cased or uncased firearms will have the action locked in an open position.
13. Firearms may be loaded on the range only when pointed downrange, at the firing line, at the assigned stall. Firearms will not be loaded behind the firing line, Dry firing is allowed in the firing line only. Dry firing behind the firing line is prohibited.
14. Never move forward of the firing line. If anything falls forward of the firing line, signal the Range Safety Office for assistance.
15. Use of the range for instruction, matches, or training for personal gain or profit by members, or for anything other than their own and their family or guests personal pleasure, is strictly prohibited without prior approval from the Executive Board.
16. Guests are welcome and must be accompanied by a member in good standing. Guests are limited to 4 per member. Club members are responsible for compliance of all range rules by their guest.

Anyone caught breaking any of the club's safety rules or range rules could be brought up on charges under Article IX of the DSRPC Bylaws. Violators can lose the membership. Desert Sportsman's Rifle & Pistol Club assumes no responsibility for any injury sustained while on DSRPC property. Come and have fun, but understand that you do so at your own risk. Any injury accidentally suffered at the hands of any individual member or guest, must be reconciled between the two or several parties. You must report all injuries to the Executive Board. This is a sporting club, practice safety and common sense in everything you do.

The strictest discipline must be maintained at all times on the firing line in order to prevent injuries. By affixing your signature below, you are indicating that you have been issued, a copy of the safety rules, have read, understand and will obey said rules.
